Learn More about the NC Innovations Waiver and Registry of Unmet Needs

The NC Innovations Waiver is a home and community-based services program that allows Medicaid-eligible individuals with intellectual and/or developmental disabilities (I/DD) to receive services and supports in their own community. This helps people live as independently as possible, rather than in an institution like a developmental center.

Although Vaya Health manages the Innovations Waiver in the 31 counties we serve, the program is funded with federal and state dollars. The NC Department of Health and Human Services assigns a set number of waiver slots to Vaya each year based on available funding. Unfortunately, there are more people who need services than there are slots available.

People waiting for an Innovations Waiver slot may choose to be added to the Registry of Unmet Needs. It is a first-come, first-serve waitlist maintained by Vaya to keep track of those eligible for a slot. Once a person is added to the list, they can choose to participate in services available in their community while waiting for a slot.
