#### A. Welcome and Call to Order

Mr. Ronnie Beale, Executive Committee Chair, called the meeting to order at 1:12 p.m. Ms. Ashley Logan, Board Support & Administrative Professional, called roll at the request of Mr. Beale, confirming a quorum of the Executive Committee.

### B. Approval of Agenda and December 13, 2024 Meeting Minutes

Mr. Billy Kennedy made a motion to approve the Agenda and Meeting Minutes, as presented. Ms. Nancy Baker seconded the motion. Motion unanimously approved.

#### C. Report of the Chair

Mr. Ronnie Beale, Executive Committee Chair, expressed his appreciation to Vaya and all the Staff for the support shown during the Hurricane Helene relief efforts. Mr. Beale spoke about the effects the disaster has had on our communities.

#### D. Report of the Area Director and Chief Executive Officer

Ms. Tracy Hayes, Area Director & Chief Executive Officer, began by expressing her appreciation to Ms. Ashley Logan, Ms. Gwen Hensley, and Ms. Mickey Hilbert for their efforts supporting the Annual Board retreat.

Ms. Hayes informed the Committee that the biggest impact we are seeing from Hurricane Helene disaster relief is housing. In Buncombe County alone, over 9,000 residential units are uninhabitable. Many were completely destroyed, while others are deemed unsafe. The housing crisis is severe, and there is no clear timeline for when properties will be available. Ms. Hayes emphasized that we are developing strategies to support housing needs. Addressing mental health or substance use challenges is nearly impossible without safe housing. The aftermath of Hurricane Helene will have long-term impacts on Western North Carolina, but Vaya is committed to meeting our obligations across all of our counties.
